## H.R.2422 Action for Dental Health Act of 2017

Introduced on 5/15/2017

This bill amends the Public Health Service Act to reauthorize oral health promotion and disease prevention programs through FY2022. The Department of Health & Human Services may award grants or enter into contracts to collaborate with state, county, or local public officials and other stakeholders to develop and implement initiatives to: (1) improve oral health education and dental disease prevention; (2) reduce geographic barriers, language barriers, cultural barriers, and other similar barriers in the provision of dental services; (3) establish dental homes for children and adults; (4) reduce the use of emergency departments by individuals who seek dental services more appropriately delivered in a dental primary care setting; (5) facilitate the provision of dental care to nursing home residents.

#### H.R.6690 Fighting Fraud to Protect Care for Seniors Act of 2018

Introduced on 8/28/2018 by Representative Peter J. Roskam (IL-6)

This bill requires the Centers for Medicare and Medicaid (CMS) to establish a pilot program that evaluates the feasibility of using smart card technology to address Medicare fraud. Under the program, smart card technology must be issued free-of-charge to selected Medicare beneficiaries suppliers, and providers; such technology must support the secure, electronic authentication of beneficiary identity at points of service. In selecting program participants, the CMS must consider the risk of fraud, waste, or abuse among categories of suppliers and providers.

## S.3580 Seniors Affordable Housing Tax Credit Act

Introduced on 10/11/2018 by Senator Dean Heller (NV)

A bill to amend the IRS Code of 1986 to provide a tax credit to taxpayers who provide reductions in rent to low-income seniors renters, and for other purposes

#### S.3560 Retirement Freedom Act

Introduced on 10/9/2018 by Senator Ted Cruz (TX)

To allow individuals to choose to opt out of the Medicare part A benefit.

## S.3545 Home Health Payment Innovation Act of 2018

Introduced on 10/3/2018 by Senator Susan M. Collins (ME)

To amend title XVIII of the Social Security Act to improve home health payment reforms under the Medicare program.

## S.3541 Reducing Costs for Out-of-Network Services Act of 2018

Introduced on 10/3/2018 by Senator Jeanne Shaheen (NH)

To amend the Public Health Service Act to establish limitations on cost-sharing for out-of-network services, to prohibit balance billing for such services, and for other purposes. 10/3/2018 Read twice and referred to the Committee on Health, Education, Labor, and Pensions.

## S.3522 Senior Scams Prevention Act

Introduced on 9/27/2018 by Senator Robert P. Casey, Jr.

To establish a Senior Scams Prevention Advisory Council. Reported to propose training for retailers, wire transfer companies and financial institutions to detect, identify, and stop fraud against older adults.

## H.R.7054 Housing Innovation Act of 2018

Introduced on 10/9/2018 by Representative Mark DeSaulnier (CA-11)

To establish an Office of Housing Innovation in the Department of Housing and Urban Development to assist in exploring and developing new approaches for increasing and diversifying the supply of housing and for meeting the challenges of housing shortages, housing affordability, and traffic congestion, and for other purposes. Grant for research and pilot projects include programs for facilitating home-sharing for elderly residents. 10/9/2018 Referred to the House Committee on Financial Services

## H.R.7012 Supporting Kinship Connections Act

Introduced on 10/2/2018 by Representative Karen Bass (CA-36)

To amend part B of title IV of the Social Security Act to provide grants to develop and enhance, or to evaluate, kinship navigator programs, and for other purposes. 10/2/2018 Referred to the House Committee on Ways and Means

# H.R.7003 To amend the Public Health Service Act to establish a health insurance Federal Invisible Risk Sharing Program

Introduced on 9/28/2018 by Representative David Schweikert (AZ-6)

Federal Invisible Risk Sharing Program to be administered by the Secretary, acting through the Administrator of the Centers for Medicare & Medicaid Services to provide payments to health insurance issuers with respect to claims for eligible individuals for the purpose of lowering premium for health insurance coverage offered in the individual market.

Introduced on 9/28/2018 by Representative Tom O'Halleran (AZ-1)
