Welcome & introductions, review & approval of July 13, 2018 Draft Minutes

Discussion: 2019 objectives and potential future agenda items

Committee Chair Brown stated all AICC objectives are on target. A conversation ensued and some of the suggestions included:

- Resources for first responders when they arrive at the scene of a malnourished person.
- A lead on education awareness and working with food banks to get nutritional food into the food boxes that seniors will like.
- Continued advocacy and awareness of the Older Americans Act.

Report out & discussion on AICC related research, conferences, workshops, seminars, training opportunities, best practices, or related items

Ms. Abigail Polito Hawkins reported the Alzheimer's Association will not be moving forward with SB 1357 – Dementia Training Standards. After discussions with supporters, Senator's Heather Carter and Kate Brophy McGee the decision was made to not move forward with SB 1357 rather enact an interim study committee to come up with actionable recommendations on the issue of Dementia Training Standards as the Alzheimer's Association has funding available for this endeavor.

Committee Chair Brown reported she is working on marketing and outreach for the Alzheimer's Walk in Yuma. Scheduling objectives for 2019 include Sierra Vista, Yuma, Phoenix, Tucson, Prescott and Sedona. Committee Chair Brown provided dates below for four of the Alzheimer's walks.

Yuma - October 12th Tucson - November 9th Sierra Vista - September 28th Phoenix - November 2nd

Deborah Hankerd reported the Cardinals had their Arizona Draft Day fundraiser in Tombstone, AZ on 4/27/19.
