Lisa O'Neill, Chair

Lisa O'Neill, DBH, MPH is the Associate Director of Research and Education for the University of Arizona Center on Aging, a Board of Regents Center of Excellence dedicated to promoting healthy aging through interdisciplinary programs in research, education, clinical care and community engagement, and a Clinical Assistant Professor for the University of Arizona College of Medicine, Division of Geriatrics, General Internal Medicine and Palliative Medicine. Dr. O'Neill has more than 10 years' experience in developing and implementing geriatric education and training for academic and community audiences. Her interdisciplinary research has focused on hoarding disorder, models of home care medicine, Alzheimer's disease, and optimizing resident quality of life in independent and assisted living settings. She was recently selected as a 2019-2020 Health and Aging Policy Fellow, a national program designed to build a cadre of geriatric and gerontology professionals trained to help shape a positive and healthy future for older Americans. Appointed to the Governor's Advisory Council on Aging in 2013, Dr. O'Neill has served in many leadership positions including Chair, 2017-2019. She also works with several state and regional committees dedicated to older adults such as the Arizona Alzheimer's Task Force, the Arizona Attorney General's Task Force Against Senior Abuse, and the Southern Arizona Caregiver Consortium.

Barbara Marshall has been a prosecutor with the Maricopa County Attorney's Office since 1987. She has specialized in various areas of prosecution, especially juvenile and family violence. Since 1991 she has held several management positions in almost every area of prosecution. Ms. Marshall started the first Family Violence Bureau in 1996, which included the prosecution of vulnerable adults, and the Operations Division in 2014. She has worked on various statewide legislative and policy issues, including the drafting of the original vulnerable adult abuse legislation. Ms. Marshall is currently the Division Chief of the Organized Crime Division, comprised of several prosecution bureaus, including financial crimes against the elderly. Ms. Marshall has been a member of the Commission on Trial Court Appointments, the Maricopa Association of Governments Regional Domestic Violence Council (Chair), the Arizona Juvenile Detention Alternatives Initiative Steering Committee, the Maricopa County Commission on the Seriously Mentally Ill, the Maricopa County Veteran's Court Committee, the Arizona Prosecuting Attorneys' Advisory Council Rules Committee and numerous other County and State level committees. Ms. Marshall also chairs the Maricopa County Attorney's Office Hiring and Ethics Committees. She was the recipient of a Lifetime Achievement award from the Arizona Prosecuting Attorneys Advisory Council in 2018.

Steve Wagner is President and Founder of The RightCare Foundation, Inc., an Arizona non-profit corporation and 501(c)(3) Public Charity, founded in 2010. RightCare exists to advocate for and promote best practice care in local communities. Since 2010 Deborah Hankerd has served as the manager of the Old Firehouse Senior Center in Tombstone Arizona, serving the seniors of Tombstone and surrounding areas. The Old Firehouse Senior Center provides a congregate meal service Monday through Friday, serving more than 12,000 meals every year. Mrs. Hankerd is Serv-Safe certified and organizes the daily meal logistics including developing the menus and cooking. She also manages approximately 30 volunteers. The Senior Center collaborates with the City of Tombstone, the Tucson and Tombstone Community Food Banks, the Southeastern Arizona Governments Organization (Area Aging on Aging, Region VI) and the Arizona Department of Economic Security Division of Adult and Aging Services for food and supply donations. Various educational and socialization activities are also offered to older adults including nutrition and exercise classes, bingo, bunco, computer help, and line dancing. Previously Mrs. Hankerd lived in Anchorage, Alaska for 35 years working with her husband in running several family owned businesses including a construction company.

Lee H. Olitzky, Council Member

Mr. Olitzky is the Vice President of the board of the Tucson Housing Foundation, board member of the Marshall Home for Men and the Casitas on Broadway, a HUD elder housing project. He has a MA degree in Gerontology from the University of South Florida, School of Aging Studies. Past positions of leadership include: the former Director of the New England Gerontology Center at the University of New Hampshire; Grants and Contracts Manager, Massachusetts Department of Elder Affairs; Associate Director of the Miami Jewish Health Systems; and CEO of Handmaker Services, Tucson, AZ.
